





CTA part-time program

Frequently Asked Questions

- 1. I am a CTA L1 2024 student which class will I proceed to in January 2025? CTA L1 2024 students who pass their end of year exams will proceed to the 2nd semester of the CTA part-time program in January 2025. They will therefore complete their CTA in November 2025 as per their original calendar. Students who fail in the end of year exams will join the CTA part-time program first semester and will therefore now complete their CTA program in 18 months.
- **2.** Are supplementary exams available for the CTA L1 2024 end of year exams. As in previous years students who fall within the range of 40 to 49 marks will be eligible to write a supplementary exam. A candidate can be awarded a maximum of two supplementary exams.
- 3. Under the new CTA Part-time Program, what is meant by summative assessments every semester? Only students that meet the pass/proceed criteria for each semester will be eligible to register for the next semester. If a student does not meet the pass mark for the respective semester thy will need to repeat that semester before they can proceed to the next semester.
- **4.** Will there be supplementary exams under the new program structure? For the new 18 months CTA Parttime Program, supplementary exams will only be available for the third and final semester.
- 5. Under the new CTA Parttime Program will one still be expected to pass all four courses in one exam sitting? For first semester only should a student not succeed in all four modules they will be required to repeat only the modules they failed. Once they have passed all four modules, they will then be eligible to register for second semester. For second and third semester, due to the integrated structure of the exams a student will be required to pass all the modules in that semester in one sitting.
- 6. I completed my BCTA in 2023 and proceeded to join the CTA L1 2024 class. If I am not successful in my CTA L1, can I use my BCTA to join 2nd semester of the CTA parttime program in Jan 2025? Only students who completed their BCTA qualification from 2024 going forward are eligible to register for the CTA parttime program second semester.
