How Does it Work


The 2025 CTA Part-time Program is tailored for working students, offering flexibility without compromising on quality.

- Duration: **18 months**, structured into three semesters.
- Class Schedule: Block classes held once a month, combined with a minimum of two evening Online tutorials per week.
- Designed for Working Students: The program's flexible schedule allows students to complete their studies while meeting the requirements of their training contract. It was designed in consultation with employers.
- Learning Load Distribution: Subjects are spread over 18 months, easing the workload for students with demanding work schedules.

Module summary

- Financial Accounting and Reporting [FAR]: Teaches students how to prepare and analyse financial statements in accordance with International Financial Reporting Standards (IFRS). It also equips students with the skills needed to leverage technology and data in accounting and finance decision-making.
- Management and Financial Accounting [MAF]: Teaches Students to develop expertise in budgeting, forecasting, and decision-making tools for internal management use. Teaches students to cover advanced principles of corporate finance and investment analysis for strategic decision-making.
- TAXATION [TAX]: Teaches students to provide a thorough understanding of tax principles and their application in various business contexts.
- AUDITING [AUD]: Teaches students to impart knowledge on the process and principles of auditing, as well as the importance of internal controls. It also teaches students to explore ethical considerations and corporate governance structures in modern business.

Our CTA part time program has been designed in line with CA2025/CA of the Future Competence Framework in line with the new ICAZ Initial Assessment of Competence Exam.





Intakes

The CTA part-time program offers two intakes per year, in January and July—allowing flexibility for students to begin their studies at a time that suits them.

Duration:

The program is done over a period of 3 semesters that is one and half years. Summative assessments are written each semester.

Venue & Lecture Approach:

The mode of lecture delivery is a blended learning entailing both online lectures and physical contact sessions as follows:

Certification

Upon Completion of the CTA part-time program students are awarded the ZCTA certificate by the Institute of Chartered Accountants of Zimbabwe.



Progression Rules

First Semester: Students are required to retake only the modules they did not pass in the previous term.

Second Semester: Students must successfully complete all modules within the semester to progress further.

Third Semester: Students are expected to pass all modules within this semester. However, if they do not pass, a supplementary exam option is available for additional support.

Entry Requirements

Applicants accepted for CTA must have relevant accounting qualifications, which are within:

Completed a pure Accounting Degree with a degree class of 2.2 or better/equivalent (with a minimum of 360 credits), covering the 4 core modules at the advanced level:

- Management Accounting & Finance
- Financial Reporting
- Taxation
- Auditing & Assurance
